What's New in the Photoshop CC 2018?

With increasing reports of loss of vision for no apparent reason, it is important that clinicians recognize these symptoms in order to identify etiologies. We reviewed the cases of 13 patients (age range 5-70 years) with sudden loss of vision (18 eyes), symptoms lasting no longer than 7 days, and a history of no prior ocular complaints. Visual acuity ranged from 20/20 to light perception (LP) in a horizontal meridian (5 eyes). Intraocular pressure was 15 to 40 mm Hg, and visual fields were within normal limits except for a superior arcuate scotoma in 1 eye. Retinal examination included a yellow-white subretinal lesion in all cases, except 2 (1 with normal fundus and 1 with atrophic disc). Fluorescein angiography showed blocked fluorescence in the disc. A variety of treatment strategies ranging from cryotherapy to surgery was performed. Some of the patients improved their vision. Some needed no treatment and some lost vision. One patient lost light perception in both eyes and remained blind. Loss of vision may be a symptom of a new entity, previously not recognized in the differential diagnosis of retinitis pigmentosa, or it may be an ocular symptom of a systemic disorder in an otherwise healthy person.
